PRISMA: Better Care and Increased Office Efficiency

"PRISMA allows us to get into any hospital system or any Progress Note, imaging, or x-rays that the patient had from an ER or another facility," said Provida's Dr. Luis I. Salazar. "We're able to get all that information at the point of care. And the best thing is that it's free!"

PRISMA gathers records in the Carequality® and CommonWell® Health Alliance interoperability networks, whether from another primary care practice, specialist, hospital, or urgent care center — regardless of which EHR they use.

The provider can then access a searchable timeline view of a patient's medical history, helping them detect patterns, search for diagnoses and medications, or focus on the most clinically relevant information.

Dr. Salazar said. "Looking at the information we received through PRISMA, as well as the imaging from the ER, affected the treatment for this patient and gave us a really good idea of what PRISMA could do for us."

In addition, he noted, PRISMA reduces phone calls and searches by his medical assistants.
